## Bullet

Trace Element

**A liquid formulation of trace elements purposely formulated for rapid uptake to correct trace element deficiency or supplement element uptake for maximum quality.**

Micronutrients in balanced ratios for optimal grass growth. Contains a range of chelation agents to provide targeted release over the desired time period and stability across the pH range. The specialised chelating agents used will also assist the plant in accessing bound nutrients already in the soil.

### Application:

Apply at a rate of 2.5–5 litres per hectare in 200 litres of water. Apply evenly, avoid overlapping or missing areas, using a suitable calibrated sprayer.

If there is no rain within 2 days of application irrigate the treated area thoroughly. Do not apply in hot, dry weather or frosty conditions.

Half fill the sprayer with clean water. Add concentrate as required and mix thoroughly whilst adding remaining water.
