RESTRICTIONS

- Do not apply to crops suffering from stress due to drought, frost, water logging, poor nutrition, adverse soil conditions, pest or disease incidence.
- Do not apply during hot conditions, in hot weather spray in the evenings.

PROBLEMS CONTROLLED

Caste Off can be used for the suppression of wormcasts.

CROP SPECIFIC INFORMATION

Rate of Use

For wormcast suppression only:

Powered Sprayer: 4 litres per hectare in 500 -1000 L water

Knapsack Sprayer: 40 ml/100 m² in 20 litres water Watering can: 8 ml/20m² in 10 litres water

Timing

Apply when turf is actively growing.

This is normally between Spring and Autumn.

For use against worm casting repeat at 4 monthly intervals.

Application should be made after cutting. Do not mow for at least 48 hours after application.

MIXING AND SPRAYING

Add half the required volume of water to the spray tank. Add the recommended quantity of CASTE OFF to the spray-tank. Agitate whilst topping up the tank and use continuous agitation during spraying.

Ensure that the sprayer is clean, in good working order and calibrated accurately to the sprayer manufacturer's recommendations. Particular care must be taken to remove any trace of herbicides form previous spray applications. Small traces of some materials, especially hormone herbicides can cause damage to crops. For ground crops use a conventional sprayer fitted with fan or cone jets. Excessive pressure should be avoided.

COMPATIBILITY

CASTE OFF is suitable for a large number of tank mixtures. It is important to follow the recommendations of the other product when using a tank mix with CASTE OFF.
