# **OPERATOR PROTECTION**

# **DIRECTIONS FOR USE**

**IMPORTANT:** This information is approved as part of the Product Label. All instructions within this section must be read carefully in order to obtain safe and successful use of this product.

#### **WARNINGS**

Do not apply Ringer during drought conditions. Do not apply Ringer to frozen turf.

# PROBLEMS /PESTS CONTROLLED

For use on established turf to help suppress worm casting.

### **TIME OF APPLICATION**

Between Spring and Autumn.

### **RATE OF APPLICATION**

Worm Casting

400ml in a minimum of 100 litres of water treats 1000m<sup>2</sup>

#### MIXING AND SPRAYING

Apply as a MEDIUM spray as defined by BCPC. Apply through a conventional hydraulic sprayer (including a knapsack sprayer). Half fill the spray tank with clean water and start the agitation. Shake the container well before use and pour in the required amount of product. On emptying the container, RINSE CONTAINER THOROUGHLY by using an integrated pressure rinsing device or manually rinsing three times. Add washings to sprayer at time of filling and dispose of container safely. Wash equipment thoroughly after use.
